19th SCHOLARSHIP

Dear Sisters and Brothers,

*As your President I want to proudly announce that our scholarship award program created in 2004 has been a tremendous success. So far a total of 144 of our members' children attained awards of which 90 won \$1,000 each as a winner and 54 won \$100 each as a qualified alternate. This year again, for the **Fall of 2023**, we will be awarding five scholarships each worth \$1,000 and three alternate scholarships of \$100 each.*

*The selection will be made by a lottery, among the qualified candidates, at the **April 24, 2023 General Membership** meeting. To qualify for the scholarship, the following requirements must be met:*

- 1. Any child or grandchild, of an active member in good standing* is eligible.*
- 2. The applicants must be enrolled for the Fall of 2023 in a two-year or four-year undergraduate program in an accredited college/university. The student can be a freshman, sophomore, junior, or senior and can apply every year for the scholarship. Trade schools are not eligible.*
- 3. Proof of Bursar's receipt or an official letter on school letterhead showing payment status, etc. into the college/university or proof of continuation at the college/university must be submitted to the committee.*
- 4. A copy of the child's birth certificate or grandchild's birth certificate with a copy of the appropriate parent's birth certificate.*

Make sure your completed application with all supporting documents, is emailed at Local1407Scholarship@gmail.com no later than April 30, 2023.

The Executive Board and the General Membership, with the recommendation of the Education Committee of Local 1407, have voted for these scholarships in 2004 as a way of showing our members, how much we value them and their families. I hope that these scholarships will give incentive to those who win. Best of luck to you all!
